Step 1. Set-up Your Account

WANT TO CREATE YOUR OWN ACCOUNT? GO TO WWW.BANCLIST.COM AND CLICK "CREATE A BANCLIST ACCOUNT" TAB. REVIEW AND ACCEPT AGREEMENT AND COMPLETE "MEMBER INFORMATION" PAGE.

AN ACTIVATION LINK WILL BE SENT TO YOU. CLICK LINK, ENTER YOUR USERNAME (EMAIL ADDRESS) AND THE PASSWORD YOU CREATED (MIN. 8 CHARACTERS), CLICK LOGIN TO START.

CLICK **MY FAVORITES** TAB FROM QUICK LINKS TABS ON LEFT SIDE OF PAGE AND ADD YOUR BANK AS A FAVORITE. YOU'LL RECEIVE INSTANT ALERTS OF ACTIVITY.

WANT BANCLIST TO CREATE YOUR ACCOUNT? CALL (877) 257-0854 AND REMAIN ON THE LINE. OUR SUPPORT TEAM WILL SET UP AND ACTIVATE YOUR ACCOUNT. YOU CAN SIGN IN ANYTIME.

Step 2. View, Create, Respond to Listings

- VIEWING LISTINGS — SIGN IN, CLICK FAVORITES TAB, CLICK PROGRESS BANK AND TRUST
- *ENTER RESTRICTED ACCESS CODE WHEN PROMPTED*
- CLICK VIEW TAB AFTER A LISTING TO SEE DETAILS; RESPOND TO A LISTING BY CREATING YOUR MESSAGE
- CREATE A LISTING BY CLICKING "CREATE NEW LISTING"
- COMPLETE ALL FIVE FIELDS AND CLICK SUBMIT

Step 3. Communicating With Shareholders

- SHAREHOLDERS MAY OR MAY NOT RECEIVE RESPONSES TO THEIR LISTINGS
- YOU WILL RECEIVE AN EMAIL ALERT WHEN SOMEONE RESPONDS TO YOUR LISTING(S)
- TO VIEW A MESSAGE, CLICK *MY MESSAGES* TAB FROM *QUICK LINKS* TAB TO VIEW MESSAGE(S)
- IF YOUR COMMUNICATION WITH ANOTHER SHAREHOLDER MAY LEAD TO A POTENTIAL TRANSACTION, YOU AND THE OTHER PARTY MUST CONTACT THE BANK TO PROCEED (*NOTE: BOTH PARTIES TO A POTENTIAL TRANSACTION SHOULD PROVIDE THE OTHER PARTY WITH SOME CONTACT IDENTIFICATION BEFORE AGREEING TO CONTACT BANK*)
- ONLY THE BANK CAN COMPLETE A TRANSACTION
